

Objectives:

- Discuss systemic racism, diversity, and allyship in the field of toxicology. Explore examples of environmental injustice, their public health implications, and the role of toxicology.
- 2. Review the pharmacology, physiology, and toxicology of drugs in breast milk and the medico-legal implications.
- Summarize clinical studies describing the use of calmangafodipir in the treatment of acetaminophen toxicity, and explain how knowledge of a patient's genetic information can help individualize patient therapies.
- Provide an overview of the toxicologic challenges facing the Middle East and North African regions, including snake envenomations and natural poisons unique to those areas.
- 5. Discuss the toxicity of approved and unapproved therapies used in the treatment of COVID-19, and the changes in poisoning epidemiology and severity during the COVID-19 pandemic in Europe.
- 6. Debate the pros and cons of the antidotal use of physostigmine and lipid emulsion therapy.
- 7. Explore risk factors for adverse drug events in the emergency department, mitigation strategies to prevent errors, and an evidence based approach to restarting medications following overdose.
- 8. Identify oral chemotherapeutic exposures requiring specific management, and explore methotrexate toxicity and treatment strategies.
- Illustrate the dangers of often overlooked pediatric occupational exposures, review industries in which child labor is frequently utilized, and discuss workplace assessment and child labor laws.
- 10. Describe the impairing effects of various drugs on driving skills, and explore multiple aspects of impaired driving including: impaired driving recognition, litigation, and prevention initiatives.

Dr. Daniel Ciccarone is the Justine Miner Professor in Addiction Medicine, in the department of Family and Community Medicine, at UCSF. He has been principal or co-investigator on numerous NIH sponsored public health research projects including his current Heroin in Transition study. He is a recognized international scholar on the medical, public health and public policy dimensions of substance use, risk and consequences. He is Associate Editor for the International Journal of Drug Policy and recently edited an IJDP special issue on the "triple wave crisis" of opioids, heroin and fentanyl in the US. He consults for numerous private and public entities including the ONDCP, CDC and FDA.

Straight Talk About Stigma: An Educator's Approach

Sunday, October 17, 9:30am-11:00 am

Millions of people in the US live with a substance use disorder (SUD). Healthcare providers have effective tools to treat SUD, including medication-assisted treatment (MAT), but they are not utilized widely enough, in part due to stigma.

Session attendees will analyze the social consequences related to the stigmatization of substance use, and what poison centers can do to help reduce the burden. This session will be led by frontline non-profit leaders.

Improving Accessibility for Health Literate Digital Content Saturday, October 16, 10:00am-11:00am

From social media and websites to virtual presentations and videos, digital and online content is both a necessity and a likely reality for reaching our audiences with important poison prevention messages.

Expanding on the 2020 NACCT session addressing healthy literacy, this session will focus on the application of health literacy principles in digital outreach and education.



Debunking misinformation Saturday, October 16, 10:00am-11:00am

Misinformation, both perpetuated by those in bad faith or those who missed opportunities in times of crises, can have harmful effects on individual and public health. This session will be virtually led by the Johns Hopkins Center for Health Security, where they will outline their priorities for a national strategy to combat online misinformation, including their lessons learned from Ebola and COVID-19.

The session will also instruct on best practices for communicating about science, with the special aim of elevating poison control centers as a trusted source of medical information.
