RESEARCH ABSTRACT

My research interests lie at the intersection of emergency medicine and medical toxicology, with a particular focus on the antidotal management of poisoned and critically ill patients. My prior work emphasized the identification of novel drugs of abuse, including one of the earliest descriptions of counterfeit drug products containing fentanyl. I have also focused on the use of specific antidotes including physostigmine for the treatment of antimuscarinic toxicity, and high dose insulin euglycemic therapy for calcium channel and beta blocker poisoning. My current research interests have expanded more broadly to the development of national treatment guidelines with the American Heart Association for the management of patients with life threatening poisoning and drug overdose. Of particular interest is the use of venoarterial extracorporeal membrane oxygenation in the treatment of life threatening poisoning. I have extended my interest in the care of critically ill patients, including those in cardiac arrest as a member of the 2025 Special Circumstances in Cardiac Arrest writing group, who reviews all available literature to inform the care of patients in cardiac arrest from specific causes, such as pulmonary embolism. I was recently invited to become a member of the International Liaison on Resuscitation, an organization that provides ongoing, rigorous and structured review of primary literature to develop evidence-informed international guidelines for resuscitation and first aid. Moving forward, I aim to continue to improve emergency medicine, medical toxicology, and addiction medicine care and advancing evidence-based treatment guidelines for poisoning and drug overdoses.
