Throughout my training in medical toxicology and subsequent appointment as a consultant (attending) in 2007, I have been an avid supporter of the AACT and the NACCT annual congress. Through my AACT engagement, I have formed both personal and professional relationships with many individuals within the AACT. Additionally, on behalf of the AACT, and its sister organisations the EAPCCT and APAMT, I have become involved in a number AACT related US and international clinical toxicology projects. I have taken also taken on a variety of additional roles on behalf of AACT. The value of international collaboration is vital not only to the development of the field of Clinical Toxicology, but to dealing with some of the challenges such as controversies in management and shortages of treatments/antidotes.

In applying to be a Trustee of the AACT Board of Trustees, my vision is to “improve and increase the international participation in the activities of the AACT” and my goals include:
